AIRSPACE D (CTR) MUENCHEN (EDDM) AND OBERPFAFFENHOFEN (EDMO) AS WELL AS THE RESTRICTED AREA EDR MUENCHEN ARE EXCLUDED FROM THE RMZ/TMZ MUENCHEN. IN THE RMZ/TMZ MUENCHEN ALL VFR FLTS, EXC FOR FLTS BY THE POLICE FORCES AND ON BEHALF OF THE POLICE, FLTS ON RESCUE AND DISASTER CONTROL MISSIONS, ACTUAL AMBULANCE FLTS AS WELL AS MODEL ACFT AND UAS UP TO 120M AGL SHALL USE THE FREQ 135.600MHZ WITH THE CALL SIGN - POLICE INFO- AND SHALL SQUAWK CODE A6375 WITHOUT BEING REQ TO DO SO. IF NECESSARY - POLICE INFO- WILL ASSIGN AN ALTERNATIVE SSR CODE. INSIDE RMZ OBERSCHLEISSHEIM THE FREQ 131.130MHZ SHALL BE USED. BEFORE ENTERING THE RMZ/TMZ, AN INITIAL CALL CONTAINING THE FOLLOWING INFORMATION SHALL BE MADE:

-DESIGNATOR OF THE STATION BEING CALLED, -CALL SIGN AND TYPE OF ACFT,

- POSITION, LEVEL AND FLT INTENTIONS.

CONTINUOUS AIR-GROUND VOICE COM WATCH SHALL BE MAINTAINED ON FREQ 135.600MHZ (POLICE INFO) WHILE FLYING WITHIN THE RMZ/TMZ. ACFT SHALL ALSO REPORT WHEN LEAVING THE RMZ/TMZ. IF THE AERONAUTICAL STATION CALLED DOES NOT ANSWER, THE FLT THROUGH THE RMZ/TMZ MAY STILL BE CONTINUED AS LONG AS AIR-GROUND VOICE COM WATCH IS MAINTAINED. RADIOTELEPHONY REPORTS SHALL STILL BE MADE EVEN IF THE AERONAUTICAL STATION DOES NOT RESPOND.

THESE REGULATIONS DO NOT APPLY TO IFR FLTS.)
